



Pony Drugging Scandal: Pingle Goes Down, Agni Cleared

No surprise in court as Pingle gets sentenced



In an evening of high drama at the TT Courtroom presided over by the Honourable Judge Danaira, all charges against Agni were dismissed and to no nobody's surprise Pingle was found guilty.

The proceedings were ably overseen by Court Clerk Aida Beorn with the prosecution led by renown TT lawyer Jane Sorrowman and the defence led by Devi Ernshaw with support from Agni Kiyori who defended herself.
